

# REQUEST FOR QUALIFICATIONS - ARCHITECTS WINDGATE ADDITION RFQ# AX-23-001

The University of Arkansas at Fort Smith, in accordance with the policies of the Board of Trustees, is soliciting responses from qualified architectural firms for the Windgate Addition.

#### PROJECT DESCRIPTION

The Windgate Art & Design Building at the University of Arkansas at Fort Smith is located at the southeast corner of the campus. It is home to the university's art department, including the studio art and graphic design majors. In addition, the building includes several galleries and a theater providing opportunities for events, meetings, and gatherings. Windgate Art & Design was built in 2015; the current building is 57,000 square feet with 2,500 square feet of gallery space.

As the university expands its current academic offerings, an additional 19,876 square feet to the existing Windgate Art & Design Building is needed. The addition will include key instructional spaces such as a woodshop and ceramics studio with an adjacent classroom, allowing for the development of sculptural curriculum. The expansion will consist of a reconfigured and expanded Permanent Collection storage space and Collection Study/Artwork Handling room. The papermaking facility will be expanded and re-located, allowing our Book Arts facilities a reception area and office space. The Graphic Design program will benefit from a new Digital Fabrication suite that will enable us to support all aspects of the curriculum and integrate innovative methods for materials handling, object production, and design output. The construction will include reconfiguring the Waldron Avenue entrance to make it more pronounced to the public as an obvious entrance. On the opposite end of the building, the Book Arts Center will also have a separate and distinguishable entrance built. To complement the additional spaces, a small café will be added to the first floor.

The addition's second floor will primarily consist of faculty offices and studio spaces. First and second-floor individual studios will support creative practices, provide critical area for future Artists in Residence, and offer additional studio space for students. The third floor will feature a covered veranda and rooftop patio service as unique classroom space, drawing studio, and event space.

## **PROJECT COST**

The total project cost is estimated at \$8,845,887.44 which is funded by a new gift from the Windgate Foundation. The Architect will work with a university building committee and Facilities Management to advance campus master planning and design.

To avoid potential conflicts of interest, respondents should not communicate with university or university foundation staff about this project. Include the information below and organize it in an easily accessible manner. It is not necessary to divide the response into chapters exactly matching the description below. Responses that do not include the required licensure information will be disqualified.

## 1. Proof of licensure or eligibility:

Architects: All firms shall be licensed, or eligible for licensure, in the State of Arkansas. Consulting and joint venture firms are also required to be licensed in the State of Arkansas. A copy of a valid Arkansas license must be included with the submittal.

Landscape Architects: All firms shall be licensed by the Arkansas State Board of Architects, Landscape Architects, and Interior Designs. A copy of a valid Arkansas license must be included with the submittal.

Civil Engineers: All engineers shall hold individual licenses in the State of Arkansas, and all engineering firms shall hold a valid Certificate of Authorization (COA) issued by the Arkansas State Board of Licensure for Professional Engineers and Professional Surveyors. Joint venture firms are also required to hold a COA. A copy of a valid Arkansas license must be included with the submittal.


- 2. Organizational chart for design team and all consultants.
- 3. Specific project experience (within the past five years) with design of professional-quality art galleries and studios and their spatial, acoustical, lighting, and technological requirements.
- 4. Specific project experience (within the past five years) with design of collegiate art buildings and/or a thorough understanding of NASAD accreditation requirements.
- 5. Specific project experience (within the past five years) with creating compelling urban environments through building and landscape design.
- 6. Current office size, personnel description, and workload.
- 7. Experience constructing projects under nationally recognized sustainable rating systems.
- 8. Experience with fully commissioned projects.
- 9. Proof of current professional liability insurance coverage (\$1,000,000 minimum required).
- 10. List of projects currently under contract with state agencies or educational facilities.
- 11. Statement of diversity in the workforce, if applicable.
- 12. Certificate of women-owned, minority-owned, or service-disabled veteran owned business, if applicable.

## PROFESSIONAL SERVICES REQUIRED

Programming, feasibility assessments, graphic presentation, site planning, civil engineering, landscape design, interior design, cost evaluation, schematic design, design development, construction documents, construction administration, and project closeout.
