# I. Course Information

#### A. Catalog Description

Appraises economic, political, legal and social institutions that played pivotal roles in the evolution of American racial geography. Hispanic-American, African-American, Asian-American and European-American cultures are examined.

### II. Student Learning Outcomes

### A. Subject Matter

Upon successful completion of this course, the student will be able to:

- 1. Deconstruct the concepts of race, ethnicity, racialism and racism.
- 2. Distinguish among geographic concepts of place.
- 3. Demonstrate how race and place in American metropolitan areas are closely linked.
- 4. Examine the historical and geographical contexts of racial issues in the U.S.
- 5. Compare and contrast concepts of segregation, assimilation, acculturation and integration and apply them to interpret current immigration issues.
- 6. Compare and contrast the characteristics and spatial distribution patterns of minority groups in America.
- 7. Examine the historical and geographical contexts of racial issues in the U.S.
- 8. Appraise the roles that individuals, private institutions and governmental policies play/have played in shaping contemporary geographic patterns in the U.S. as well as the racial inequalities that they foster/have fostered.

- 9. Analyze and dissect disparities in the distribution of income, housing and basic services (e.g. banks, real estate, public services) between inner cities and their suburbs, and among black "ghettos," Hispanic "barrios," and white neighborhoods in American metropolitan areas.
- 10. Compare and evaluate the lack of environmental equity/justice across demographic groups, social classes and geographic areas in urban America.

Students will reflect upon cultural differences and their implications for interacting with people from cultures other than their own.
