HIST 4213 Perspectives of Women in World History

Credit Hours: 3 Lecture Hours: 3

Prerequisite: Junior standing. Effective Catalog: 2019-20

I. Course Information

A. Catalog Description

An examination of the condition of women in history with emphasis on problems in world history; attitudes toward women as reflected in religious, legal, and philosophical literature; and the role of expectations of women in various societies.

II. Student Learning Outcomes

A. Subject Matter

Upon successful completion of this course, the student will be able to

- 1. Describe women's roles in ideological transformations in Eurasia from 1500-1750.
- 2. Summarize and explain women's roles in the exploration and exploitation of the Atlantic World, 1492-1750.
- 3. Analyze the different roles that women performed during the process of Industrialization, 1780-1930.
- 4. Formulate conclusions about women's roles during Imperialism, 1830-1930.
- 5. Explain how women lived under totalitarianism during the twentieth century.
- 6. Support explanations of how the Cold War impacted different women's lives.
- 7. Compare and contrast the differences in women's lives in colonial and postcolonial societies.
- 8. Debate issues related to feminism, neo-feminism, and anti-feminism in a global context.

III. Major Course Topics

- A. Differences between sex and gender, and matriarchy and patriarchy and how these concepts shaped realities for women around the world through time and across cultures.
- B. Women's roles in the course of the following world events:
 - 1. The creation of the Atlantic World in the wake of Columbus' historic voyage in 1492.
 - 2. The increasing state centralization in the seventeenth and eighteenth centuries.
 - 3. The emergence of social and political movements in response to industrialization and the cross-cultural exchange it fostered in the nineteenth and early twentieth centuries.
 - 4. Nationalism and Imperialism during the nineteenth and early twentieth centuries.
 - 5. The emergence of highly centralized, especially totalitarian, governments in the first half of the twentieth century.
 - 6. The emergence of Second-wave Feminism in the context of decolonization, the Cold War between the United States and the Soviet Union, and increasing globalization.
 - 7. The political and social implications of women's intellectual and artistic achievements in the last half of the twentieth century
