# I. Course Information

### A. Catalog Description

Intensive study of state and federal rules of civil procedure. Emphasizes the functions and duties of legal assistants in the litigation process, with special attention paid to the different types and proper preparation and filing of legal documents, requirements of the rules for the timing and required content of properly drafted pleadings, motions and discovery documents.

#### **B.** Additional Information

The process of litigation in our court system is controlled by a system of rules that mandate adherence. A failure to comply with the rules can result in a case being dismissed. It is essential that paralegals be familiar with the rules and their requirements and this course is designed to impart that familiarity.

### II. Student Learning Outcomes

#### A. Subject Matter

Upon successful completion of this course, the student will be able to:

- 1. Identify the appropriate court for filing a complaint.
- 2. List the stages or steps in a civil lawsuit and explain what happens during each stage and which documents and pleadings are pertinent to each stage.
- 3. List the elements in any cause of action and for any applicable affirmative defenses.
- 4. Draft a complaint, answer with an affirmative defense, a motion and order granting the motion.
- 5. Given a hypothetical fact pattern, locate the appropriate Arkansas or

federal procedural rule.

- 6. For a given hypothetical set of facts, properly identify all necessary documentation the plaintiff would need to file.
- 7. For a given hypothetical set of facts, properly identify all necessary documentation the defendant would need to file.

Students will demonstrate the ability to prepare legal documents routinely used in the area of law being taught. Students will demonstrate a comprehension and understanding of legal terminology associated with the subject matter being taught.
