University of Arkansas - Pulaski Technical College (UA - PTC) students interested in earning a Bachelor of Science in Early Childhood Education (Non-licensure) degree from the University of Arkansas - Fort Smith (UAFS) may complete the first two years (lower division coursework) of the bachelor's degree requirements at UAPTC by completing an Associate of Applied Science in Early Childhood Education. Completed UAPTC courses will be accepted by UAFS and applied to the BS degree requirements according to the UAFS Undergraduate Academic Catalog. UAFS will offer the remaining degree requirements through online courses. The transfer of general education courses required for the BS degree will be in accordance with the Arkansas Course Transfer System (ACTS) and the UAFS 75-semester-hour transfer policy related to lower division coursework.
